FREQUENTLY ASKED QUESTIONS

What is a low speed vehicle?

A low speed vehicle is a four-wheeled electric vehicle that:

Has a maximum speed capability that exceeds 20 miles per hour, but is less than 25 miles per hour;

Is designed to carry not more than four persons;

Has an unladen weight of less than 3,000 pounds; and complies with the standards for safety of such a vehicle set forth in Federal Motor Safety Standard 49C.F.R.571.500.

NOTE: A GOLF CART IS NOT CONSIDERED A LOW SPEED VEHICLE

Are low speed vehicles required to be titled and registered?

Yes, Maryland law requires all low speed vehicles to be titled and registered.

Do I need a driver's license to operate a low speed vehicle on Maryland roadways?

Yes, you must possess a valid driver's license to operate a low speed vehicle on Maryland roads.

Is a low speed vehicle restricted to only operating on roadways with certain speed limits?

Yes, a person may not drive a low speed vehicle on a roadway for which the posted maximum speed limit exceeds 30 miles per hour; or on an expressway or another controlled access highway that is signed so as to prohibit the use of these type vehicles on its roadways.
